## School responsibilities

- We accept that as a staff team we take responsibility for their academic and social development in an environment that is safe and complies with current Safeguarding legislation

## Student Responsibilities

- I will attend school and any off-site provision regularly.
- I am willing to take an active part in the curricular activities on my timetable
- I will behave safely travelling to and from, and whilst at any off-site provision, school.
- I understand that all sites are non-smoking/vaping and that I cannot go offsite unaccompanied at any point during the school day.
- I will comply with reasonable requests from staff in order that the needs and expectations of all students can be met.
- I understand and agree to follow all rules set by the UET Pathfinder Academy

## Parent / Carer responsibilities

- We/I will see that my child attends school regularly, on time and properly dressed in appropriate clothing.
- We/I accept that as parent, we/I share responsibility for the behaviour of our child at UET Pathfinder Academy with staff and our child and we/I will do my best to support the school.
- We/I agree to support the School by ensuring that our child follows the school's rules. We/I will co-operate with any behaviour strategy suggested by the School.
- We / I will let the school know about any concerns or problems that might affect my child's work or behaviour.

## All parties accept that:

- Students who are unwilling to follow the guidelines set out in this document and associated policies are denying themselves and the other students in the school the opportunity to take advantage of the curriculum and support on offer.
- At this stage in their compulsory education, responsibility for their actions must rest largely with the individual. In the event that a student does not accept this responsibility the usual school sanctions for dealing with unacceptable behaviour as stated in the School Behaviour Policy, will apply.
- In extreme cases, however, it may be necessary to exclude the student for a fixed time. A decision of this nature will be taken by a senior member of staff and parents/carers will be notified.
- All parties agree that the procedure is fair and reasonable and designed to protect the individual, the other students and the staff.
- All students are entitled to a full time education. However, both parties accept that at times young people may be unable to manage a full time programme and therefore part time provision will be provided.
- Students unable to follow this Code of Conduct will put their placement at the UET Pathfinder Academy at risk.
- Students who damage school property – Where wilful, criminal damage is caused this will be recorded on pupil files and an appropriate protective or educational consequence given. Opportunities, where possible will be provided for children and young people to work with parents/carers to put right any damage to reduce/avoid costs. Where this is not possible or appropriate, parents/carers will be charged for damage caused. Associated letters and invoices will be provided to parents/carers for payment. Any ongoing or significant incidents of damage will be reported to the Police and parents/carers will be responsible for the cost of repair/replacement.



## Consent and Agreement

- I hereby give consent for digital images of my child to be used for school display, on the website, in newspapers and for portfolio purposes.
- I hereby give consent for my child to take part in off site activities organised or run by the UET Pathfinder Academy.
- I hereby give consent for my child to go off site if accompanied by an adult
- I hereby acknowledge that I remain responsible for the actions and safety of my child on the way to and from school and whenever they are off the school site (excluding organised school trips).
- I understand that the UET Pathfinder Academy is not a permanent school and that my child may be required to move bases, or provision, to best meet their needs and the needs of other pupils.
- I understand that I have the responsibility to collect my child from the school site if my child is unwell and /or unable to safely remain in school.
- I hereby agree to provide UET Pathfinder Academy with an alternative contact in case of an emergency, to be used when I cannot be reached.
- I give consent for my child's information to be shared with other educational providers and Norfolk County Council, as necessary, in order to find an appropriate permanent educational placement.
- I hereby give consent for UET Pathfinder Academy to refer my child to an Educational Psychologist or Clinical Psychologist should this be felt necessary.
- I hereby give consent for my child to use the school computer network and internet compliant with the school ICT code of conduct.
- I hereby give consent for the school to publish on the internet my child's work subject to strict confidentiality of personal information.
